**Hispanics in Pennsylvania Must Demand True & Equal Justice for All
Learn about 2 Important Cases, where Hispanics were Victims of Hate & Injustice**

LUIS RAMIREZ (Shenandoah)

On Aug. 2008, Luis Ramirez (our Mexican brother, may he rest in peace) was brutally murdered by racists. Initially the Shenandoah Police and District Attorney's Office did NOT arrest any of the attackers, even though they had their names. However **THANKS** to the voice of **HISPANICS** and groups like **MALDEF** who demanded a full investigation, the racists were arrested and charged with a **"HATE CRIME"**. Unfortunately, at the end of the trial, justice was **DENIED** because the jurors were biased and protected their own. However, because of the continued efforts to ensure equal justice is really for all, this case is being petitioned to the Department of Justice for further investigation. Luis may not be with us, but we have and will continue to be here to ensure those guilty of his death will receive justice!

DENIS CALDERON & JULIO MALDONADO (Philadelphia)

On Aug. 1996, Denis Calderon & Julio Maldonado (Peruvian) were brutally attacked by 20+ racists in Northeast Philadelphia. While Denis was being pummeled and stabbed, Julio grabbed a "club" and swung towards the person stabbing Denis barely grazing his shoulder. The attacker took a few steps back and **COLLAPSED**. Denis was released and ran into his house to call the police. When he realized Julio was still outside and the attackers were at his porch threatening harsher violence, he grabbed a bat to back them away and to look for Julio. Denis and Julio never hit anyone with the bat or club (as later proven) but when the Philadelphia Police arrived, they automatically assumed Denis and Julio were the "bad guys". A full investigation was never done even though knives were found. The prosecutor, **SETH WILLIAMS** (most likely to be elected Philadelphia District Attorney in November) **NEVER ARRESTED ANY OF THE RACISTS**. Instead he led the wrongful conviction of Denis and Julio based on lies, misjudgment and misconduct. Seth Williams never cared these Hispanics were victims of a racial attack. Instead, perhaps in his "best" performance, he gave the attacker's family two Hispanics who "paid" for their son's demise. Even when Denis and Julio proved their innocence **TWICE** in court because the man that collapsed was never hit, **SETH WILLIAMS** appealed and won based on technicalities that overshadowed their true innocence. Today, because of immigration laws, these non-violent, lawful, long term residents are facing deportation **UNLESS** Governor Rendell issues a full pardon and DHS cancels their deportation. For this we ask you to join us as we **"Demand Justice for Denis and Julio"**

How many cases like this has **SETH WILLIAMS** executed that the public has not heard of? Just because this happened 13 years ago and the voices of Hispanics in Philadelphia were not loud enough then, does not mean we will not recognize and stand up for what's right today. As hermanos **HISPANOS** Philadelphians, we must ensure these **HATE CRIMES** are punished to the full extent of the law. These **INJUSTICES** against **HISPANICS** must **STOP NOW**.
